CANDIDATE MEMOS FOR CONGRESSIONAL CANDIDATES

You will need to write two campaign memos for this assignment. Each memo should be no more than one-page long. In the memo, you will be writing a strategic plan for a hypothetical candidate running in the primary for a U.S. Senate seat in your home state. Assume that the candidate is running for an open seat (i.e., there is no incumbent in the race) and that they are a member of the party that won your state in the most recent presidential election. Each memo should include the following sections:

- To/From/Date/Subject header
- Race overview key facts about the politics of the state
- Target voters which voters the campaign should focus on
- Messaging key issues that the candidate should discuss during the primary
- Tactics the key strategies to reach and persuade voters

The first memo should be written for a candidate running in a traditional primary where the candidate is only competing against copartisans. The second memo should be written for a candidate running in a system like they have in Alaska (i.e. a top-4 primary that will be followed by a general election that uses ranked choice voting).
